Subsequent to decisions taken by the 27<sup>th</sup> Session of the Codex Alimentarius Commission (June 2004) the Draft Standards and related texts presented in tabular form in Annex I of the present Circular Letter are being submitted to Member governments and interested International Organizations at Step 6 of the Procedure for comments.
