

Guidelines for Veterinary Certificate for Fresh Meat for Transit and/or Storage in the European Union

Part I. Details of Dispatched Consignment

- I.1 Enter full name, address, and telephone number of entity in the US exporting the product
- I.2 Enter serial number from FSIS Form 9060-5
 - I.2.a Leave Blank
- I.3 Enter “FSIS”
- I.4 Enter FSIS District Office
- I.5 Enter full name, address, and telephone number of entity receiving the product
- I.6 Enter full name, address, and telephone number of person responsible for the product in the EU
- I.7 If U.S., enter “US” and “US-0”. If from another country, enter appropriate code from attached source:

- I.8 Mark through
- I.9 For products intended for a third country, enter the name of the third country of destination and indicate ISO code. For products for U.S. military or shipstores in the EU, enter the EU country and ISO code.*
- I.10 Leave Blank
- I.11 Enter Establishment name, address, and Est. No. of originating establishment
- I.12 Enter name, address, and Est. No. of place of destination in the EU. If a military shipment, indicate “military shipment” and provide destination information. If ships’ stores, indicate “ships’ stores” and provide destination information.
- I.13 Enter place of loading
- I.14 Enter date of shipment departure – should not precede the date in the signature block of the certificate.
- I.15 Complete as appropriate: Mark through “railway wagon, and road vehicle and other.” Indicate “Aeroplane” or “Ship” as appropriate, and provide ship name or airline flight number/s
- I.16 Enter Boarder Inspection Post (BIP) in the EU, point of first arrival
- I.17 Enter “NA”

- I.18 Indicate animal species and description of product as labeled
- I.19 Use the appropriate HS code: 02.01, 02.02, 02.03, 02.04, 02.05, 02.06, 02.08.90, 02.09, or 15.02
- I.20 Indicate total gross weight and total net weight
- I.21 Check appropriate box
- I.22 Enter No. of pieces or packages
- I.23 Enter container and seal number, if applicable
- I.24 e.g. cans, cardboard, plastic, etc
- I.25 Check box "Human consumption"
- I.26 Identify third country destination and indicate ISO code.

- I.27 Leave blank
- I.28 Identification of the commodities
- Enter information as appropriate
Complete with scientific name, such as: bovine; ovine; caprine; domestic equine; domestic porcine, etc.
Nature of commodity, complete as appropriate
If frozen, indicate the date of freezing (mm/yy) of the units/pieces
Abattoir: Slaughter Est. No.
Cutting Est. No.
Processing Est. No.
Number of packages
Total Net weight in metric

II.2. Animal Health Attestation

II.1.2. Mark through the non-applicable certificate references. BOV (beef-bison) / OVI (sheep-goat) / POR (pork) / EQU (horsemeat) / RUF (farmed non-domestic animals other than porcine-equine) / RUW (wild non-domestic animals other than porcine-equine) / SUF (farmed non-domestic swine) / SUW (wild boar) / EQW (wild horse)

II.1.3. Add date or range of dates of slaughter.

Signature Block

Name of Official Veterinarian (in capitals)

Date- should match the issue date of FSIS Form 9060-5

Place – Enter city and state where export originated.

Stamp- Apply the rubber USDA export stamp in a color other than black. The certificate number shown on the stamp is the certificate number of the certificate.

Qualification and title

Signature- ink signature in a color other than black

Enter the certificate number from FSIS Form 9060-5 into Block II.a. at the top of pages 2 and 3.
The FSIS veterinarian signs the bottom of pages 1-3 in the space provided.
