The program employee can obtain the owner's or custodian's signature and provide the signer with a copy (the original is retained by the program employee), before the actual destruction, if an accurate accounting can be obtained. In instances where complete voluntary destruction is not performed due to large amounts, etc., a partial destruction can be recorded signed/dated on form. Completion date will be recorded by program employee when <u>all</u> the subject product is voluntarily destroyed. Additionally, when the product is actually destroyed, either that same day or later (within 20 days), if detained, the detention is terminated. The Notice of Termination of Detention, FSIS Form 8400-1, will be completed.
