**DATE DETAINED** - The date product was detained.

**OWNER'S NAME, ADDRESS, AND TELEPHONE NUMBER** - Enter the full organization name or individual, address and telephone number of the owner of the detained product.

**CUSTODIAN'S NAME, ADDRESS AND TELEPHONE NUMBER** - Enter the full organization name, address, and telephone number of the custodian of the detained product. Enter "Same as owner" if applicable.

**Block 1. DISPOSITION CODE** - Indicate the reason for terminating the detention by checking the appropriate block. Complete data where applicable.

Block 2. PRODUCT WEIGHT (lbs.) -Indicate the weight (in pounds) of the product.
