FSIS Finds Ireland Beef Processes Equivalent to the U.S.

FSIS conducted an on-site audit of Ireland's Department of Agriculture, Food, and the Marine (DAFM) food safety inspection system from June 30 – July 7, 2014. This audit has concluded that DAFM has implemented a beef slaughter inspection system that is considered to be equivalent to FSIS' domestic inspection system.

The request by Ireland to ship beef carcasses, including halves and guarters, to the United States is a reinstatement of their prior equivalency determination to ship beef, which was stopped in 1998. This reinstatement represents the first action to ship beef to the United States from a member country of the European Union. Draft Establishment-Specific Data Release Strategic Plan Now Posted

Today, FSIS posted the Establishment-Specific Data Release Strategic Plan (the draft Plan) for sharing data on federally inspected meat and poultry establishments with the public at *http://www.fsis.usda.gov/ wps/wcm/connect/98c33278-53dd-4228-a695-54f429cf4413/Establishment-Specific-Data-Release-Plan. pdf?MOD=AJPERES*. FSIS also posted an advanced copy of a *Federal Register* notice announcing the availability of the draft Plan at *http://www.fsis.usda.gov/wps/portal/fsis/topics/regulations/federal-register/ federal-register-notices*.

FSIS developed the draft Plan in response to memoranda released by President Obama and the Office of Management and Budget (OMB) that called for: increased data sharing; an Executive Order for agencies to develop plans for making information available to the public; review of National Advisory Committee on Meat and Poultry Inspection (NACMPI) recommendations; as well as those from the National Research Council (NRC).

FSIS is providing 60 days for public comment, and may update the draft Plan in response to comments. Extended Comment Period for the Economic Analysis for Shiga Toxin-Producing *E. coli* (STEC) in Certain Raw Beef Products

On Nov. 19, 2014, FSIS published a *Federal Register* notice announcing that it had completed and was making available its analysis of the estimated costs and benefits associated with the implementation of its non-O157 STEC testing of beef manufacturing trimmings and the potential expansion of its non-O157 STEC testing to ground beef and ground beef components other than beef manufacturing trimmings. In addition, the agency was responding to comments that it had received on the previous cost-benefit analysis on this subject. The deadline for submitting comments on the analysis discussed in the notice is Jan. 20, 2015.

FSIS extended the comment period in response to a request from an industry association. The new deadline for submitting comments is Feb. 19, 2015.
