# **FSIS to Hold Educational Meetings** for Importers on Inspection of Siluriformes Fish

FSIS will be conducting a series of educational meetings regarding the new final rule, "Mandatory Inspection of Fish of the Order Siluriformes and Products Derived from Such Fish," which was published in the Federal Register on Dec. 2, 2015. The purpose of the meetings is to explain and review the regulatory requirements contained in the final rule as they apply to importers.

The final rule, which applies to both domestically-raised and imported Siluriformes fish, becomes effective March 1, 2016, with an 18-month transitional period. During the transitional period, FSIS will provide guidance and work with domestic establishments and importers to ensure that they understand FSIS' requirements. ### The Food Safety Discovery Zone Tour Starts Next Month

The USDA's Food Safety Discovery Zone (FSDZ) will be back on the road next month. The FSDZ will be at the B'More Healthy Expo at the Baltimore Convention Center, 1 W Pratt St, Baltimore, MD on March 19, 2016 from 10 am – 5:00 pm. FSDZ will also visit the USA Science and Engineering Festival at the Wash-ington Convention Center, 801 Mt. Vernon Pl NW, Washington, DC on April 15 -17, 2016.

On April 23, 2016, the FSDZ will be at the Jenks Herb and Plant Festival in Main St. Jenks, OK. They will also be at the Worth Mayfest at 2401 University Drive, Ft. Worth, TX on April 28 - May 1, 2016.

The FSDZ is a 40-foot interactive vehicle that educates consumers about the four food safety messages: Clean, Cook, Separate and Chill from the Food Safe Families campaign. Some of the features in the vehicle include a Hand Washing Station, where visitors can learn the proper techniques to washing hands, and a cook station that showcases how to properly use a food thermometer to verify foods have been cooked to a safe internal temperature. More events will be announced in the coming months.
