Dear Ms. Sutherland:

This is the final response to your Freedom of Information Act (FOIA) request, dated January 2, 2020, to the U.S. Department of Agriculture's Food Safety and Inspection Service (FSIS). You requested access to A copy of records related to humane handling and slaughter, from October 1, 2019 to December 31, 2019. We received your request in our office on January 2, 2020.

The FSIS FOIA staff works with subject matter experts across the agency to locate responsive documents. For this request, we conducted a records search in the Office of Planning Analysis and Risk Management. FSIS' search began on January 02, 2020. Our search includes responsive records in FSIS' control on that date.

We have located 186 pages that are responsive to your request. After a thorough review, we have determined that portions of these documents are exempt from disclosure under (b)(4), (b)(6) of the FOIA, 5 U.S.C. § 552, as amended. Accordingly, this request is granted in part.

Portions of the responsive records are exempt from disclosure under FOIA Exemption 4, 5 U.S.C. § 552(b)(4). Exemption 4 protects trade secrets and commercial or financial information obtained from a person that is privileged or confidential.

Portions of the responsive records are exempt from disclosure under FOIA Exemption 6, 5 U.S.C. § 552(b)(6). Exemption 6 protects information that would constitute an unwarranted invasion of an individual's personal privacy. The types of information withheld under Exemption 6 include the names, addresses, or cell phone numbers of employees of Establishments and third parties, including, but not limited to interviewees or customers.

You may appeal this determination no later than 90 days from the date of this letter. Your appeal should include copies of your original request and this response, as well reasons supporting your appeal. The envelope should be plainly marked to indicate that it contains a FOIA appeal. However, FSIS does not release your personal privacy information, such as home addresses, telephone numbers, or Social Security Numbers, all of which are protected from disclosure under FOIA Exemption 6.
