Dear Ms. Sutherland:

This is the final response to your Freedom of Information Act (FOIA) request, dated July 6, 2020, to the U.S. Department of Agriculture's Food Safety and Inspection Service (FSIS). You requested a copy of records regarding good commercial practices, from April 1, 2020, to June 30, 2020. We received your request in our office on July 6, 2020.

The FSIS FOIA staff works with subject matter experts across the agency to locate responsive documents. For this request, we conducted a records search in the Office of Field Operations, and the Office of Planning, Analysis and Risk Management. FSIS' search began on July 6, 2020. Our search includes responsive records in FSIS' control on that date.

We have located 60 pages and one Excel spreadsheet that are responsive to your request. After a thorough review, we have determined that portions of these documents are exempt from disclosure under (b)(4) and (b)(6) of the FOIA, 5 U.S.C. § 552, as amended. Accordingly, this request is granted in part.

Exemption 4 of the FOIA protects "trade secrets and commercial or financial information obtained from a person [that is] privileged or confidential." 5 U.S.C. § 552(b)(4). The exemption covers two distinct categories of information in federal agency records, (1) trade secrets, and (2) information that is (a) commercial or financial, and (b) obtained from a person, and (c) privileged or confidential. In this instance, the agency is withholding information related to trade secrets. The information was submitted to USDA by a business. We have determined that these records contain commercial or financial information that is customarily treated as private by the business submitters. Therefore, the information is considered confidential.

Portions of the responsive records are exempt from disclosure under FOIA Exemption 6, 5 U.S.C. § 552(b)(6). Exemption 6 protects information that would constitute an unwarranted invasion of an individual's personal privacy. The types of information withheld under Exemption 6 include the names, addresses, or cell phone numbers of employees of Establishments and third parties, including, but not limited to interviewees or customers.

You may appeal this determination no later than 90 days from the date of this letter. Your appeal should include copies of your original request and this response, as well reasons supporting your appeal. The envelope should be plainly marked to indicate that it contains a FOIA appeal.
