NOTICE OF SUSPENSION

This letter confirms the verbal notification given on February 29, 2024, at approximately 1058 hours, by the Food Safety and Inspection Service (FSIS) Inspection Program Personnel (IPP) of the suspension of the assignment of inspectors for slaughter operations at Puro Alentejano Iberian Pork Corp., Est. M47945, herein after referred to as “your establishment.” This action was initiated in accordance with Title 9 of the Code of Federal Regulations (9 CFR) 500.3, after FSIS determined that your establishment failed to slaughter and handle animals humanely.

Background/Authority

The Federal Meat Inspection Act (FMIA) (Title 21 of the United States Code {21 U.S.C.} 603 et seq.) provides that for the purpose of preventing the inhumane slaughtering of livestock, the Secretary shall cause to be made, by inspectors appointed for that purpose, an examination and inspection of the methods by which cattle, sheep, swine, goats, horses, mules, or other equines are slaughtered and handled in connection with slaughter in the slaughtering establishments inspected under this Act. The Secretary may refuse to provide inspection to a new slaughtering establishment or may cause slaughtering to be temporarily suspended at a slaughtering establishment if the Secretary finds that any cattle, sheep, swine, goats, horses, mules, or other equines have been slaughtered or handled in connection with slaughter at such establishments by any method not in accordance with sections 1901 to 1906 of Title 7 until the establishment furnishes assurances, satisfactory to the Secretary, that all slaughtering and handling in connection with slaughter of livestock shall be in accordance with such a method.

The Humane Methods of Slaughter Act of 1978 (7 U.S.C. 1901 et seq.) provides that Congress finds that the use of humane methods in the slaughter of livestock prevents needless suffering; results in safer and better working conditions for persons engaged in the slaughtering industry; brings about improvement of products and economies in slaughtering operations; and produces other benefits for producers, processors, and consumers which tend to expedite an orderly flow of livestock and livestock products in interstate and foreign commerce. It is therefore declared to be the policy of the United States that the slaughtering of livestock and the handling of livestock in connection with slaughter shall be carried out only by humane methods.

Findings/Basis for Suspension

At approximately 0815 hours on Thursday, February 29, 2024, IPP identified an egregious humane handling non-compliance in which a roaster pig regained consciousness after being stunned. Ten (10) roaster piglets were positioned in the knock box and were stunned using an Electrical Stunning Device (ESD) using the head-thorax stunning technique. After all the piglets had been stunned, one piglet began showing signs of consciousness with slow, rhythmic breathing, blinking, and tracking eye movement. The employee reapplied the ESD to the piglet and the piglet gave a short squeal when the ESD was applied to its head. After a head and heart stun, the piglet was rendered unconscious. After being shackled and hung, the same piglet again exhibited signs of consciousness by paddling its front legs in a motion to try to walk away. IPP notified the employee of the conscious animal, and the employee lowered the piglet to the ground. The piglet then immediately stood up and took approximately two (2) steps on the kill floor. The employee then applied a third stun using the ESD on the head and thorax and rendered the piglet unconscious, and it remained unconscious through the remainder of the shackling, hoisting, sticking, and bleeding step. IPP applied US Retain/Reject Tag # B40490289 to the knock box to prevent further slaughter of livestock; this is in accordance with 9 CFR 313.50(c). The Frontline Supervisor (FLS) notified establishment management of the recommendation for further enforcement action at approximately 1058 hours.

This incident represents a violation of 9 CFR 313.30(a)(4) which says in part “The stunned animal shall remain in a state of surgical anesthesia through shackling, sticking, and bleeding.” The incident is considered egregious because the animal regained consciousness after being stunned. The establishment has a partially documented Systematic Approach for Humane Handling; however, the program is not considered robust, and this Suspension action is being initiated.

The suspension action will remain in effect until you provide the Raleigh District Office with adequate written assurances, including corrective actions and further planned preventive measures, to assure that livestock at your establishment are slaughtered humanely. In order to resume inspected operations, you must submit corrective actions to my attention at the District Office. These corrective actions should include at a minimum the following:

1. Identify the assessment process used to determine the nature and cause of the noncompliances.
2. Identify what the assessment revealed as the likely cause of the system failure.
3. Describe the specific actions that will be taken to eliminate the cause of the failures.
4. Describe the future monitoring activities you will use to ensure that changes are implemented and are effective.

You are reminded that, as an operator of a federally inspected plant, you are expected to comply with FSIS regulations and to take appropriate corrective actions to prevent inhumane handling of livestock at your establishment. Please be advised that your failure to respond adequately to these issues may result in our initiating action to withdraw inspection from your establishment. Please also be advised that you have the right to appeal this matter.
