### Administrative Civil Penalties

FSIS may impose administrative, civil penalties for violations of the requirement in the EPIA (21 U.S.C. 1041 (c)(1)(A)) and the regulations (7 CFR Part 3.91) that consumer-packed shell eggs be stored and transported at an ambient temperature at or below 45 degrees Fahrenheit. Specifically, the EPIA provides for a civil penalty of up to \$11,198 for each violation. The amount of the civil penalty, which may be imposed pursuant to administrative proceedings, is based on the gravity of the offense, the culpability of the violator, and prior compliance history. Civil penalty actions may be resolved by stipulation agreement in lieu of an administrative complaint, by consent decision after the filing of an administrative complaint, or through an order entered after an administrative hearing. **Table 14** lists civil penalty enforcement actions and civil penalties taken or pending for the quarterly reporting period.
