



### Submit a Batch Application

To complete the steps for batched submissions, you need XML or Excel documents that meet the PHIS requirements for batch submissions. For guidance for batch requirements, visit [this link](#). For access to the PHIS Batch Export XML Schema, visit [this link](#).

- Login to PHIS as using your eAuth User ID and password
- From the left menu, click on **Batch Processing**
- Click on **Upload Files**
- Click **Select**
- Browse for the completed XML file or Excel sheet
- Click **Submit File**
- From the left menu, click **Batch Results** to see your submission
- Click the triangle arrow in the first column of the table to expand the record
- From the left menu, click **9060**
- Click the PDF icon on the application number
- Click **Sign Out**


Next, click Upload Files.




