Dear Secretary Vilsack:

I am writing in support of Farm Sanctuary's legal petition calling on the USDA's Food Safety and Inspection Service to improve the treatment of poultry at slaughterhouses immediately (petition number 13-08).

Birds represent 8.8 billion of the 9 billion animals slaughtered annually in the U.S. It is unconscionable that the USDA exempts poultry from protections provided under the Humane Slaughter Act and refuses to grant any relief under the Poultry Products Inspection Act.

Without the USDA to protect them, countless birds are subjected to abuses that would warrant cruelty convictions under federal law if cows or pigs were the victims. USDA records indicate that almost a million chickens are boiled alive every year at slaughterhouses when they miss the neck-slicer and are dropped into the scalding water bath used for feather removal while they are fully conscious.

The New York Times reported that an undercover investigator at a poultry slaughter factor witnessed:

Hundreds of acts of cruelty, including workers tearing beaks off, ripping a bird's head off to write graffiti in blood, spitting tobacco juice into birds' mouths, plucking feathers to "make it snow," suffocating a chicken by tying a latex glove over its head, and squeezing birds like water balloons to spray feces over other birds.


That such abuses (also including workers that kicked birds, sexually abused them, stomped on their heads, slammed them into walls, and squeezed their innards out just for fun while the birds were still alive) are committed against living animals occur with no repercussions or accountability is indefensible.

It is time for the USDA to act and stop the cruelty: In a review of more than 18 months of records, USDA inspectors at more than half of the poultry slaughterhouses were not doing anything on the issue of cruelty or abuse. The most the agency has done to address cruelty in poultry slaughterhouses is to tell its inspectors to be on the lookout for slaughterhouse employees who "breaking the legs of birds to hold the birds in the shackle" or "driving over live birds with equipment or trucks." The agency also asks inspectors to watch for birds "frozen inside the cages or frozen to the cages themselves." (a horrible death)

Noticing abuse is not the same as stopping it. It is time to stop the horrors committed against billions of sensitive birds. Every day in the factory farm industry, these individual animals are treated as mere commodities to be caged, crushed, abused, even boiled alive.

We cannot stand by as billions of individual chickens suffer in the factory farm industry. It is time the USDA created long overdue humane regulations for poultry slaughter. Thank you for your immediate attention to this matter.

It has wisely been said that, The greatness of a nation and its moral progress can be judged by the way its animals are treated.
