9. Animal health attestation


I, the undersigned official veterinarian, hereby certify, that the meat product described above:

- 9.1. comes from a country or region authorized for imports into the EC as laid down in Annex I to 97/222/EC at the time of slaughter of the animals from which the meat in the meat product is derived and;
- 9.2. complies with the relevant animal health conditions as laid down in the animal health attestation in the model certificate in Annex I to 97/221/EC and;
- 9.3. is derived from animals which were slaughtered and processed on or between⁽¹⁰⁾. Enter slaughter date range in dd/mm/yy format

- ⁽¹⁾ Meat products as laid down in Article 2(a) of Directive 77/99/EEC.
- ⁽²⁾ In accordance with Article 12⁽⁴⁾ or Article 13 of Directive 97/78/EC.
- ⁽³⁾ Issued by the competent authority.
- ⁽⁴⁾ Country and description of territory as appearing in the Annex to Decision 97/222/EC (as last amended).
- ⁽⁵⁾ Description of the treatment applied as laid down in the Annex to Decision 97/222/EC (as last amended).
- ⁽⁶⁾ Address (and approval number if known) of the warehouse in a free zone, free warehouse, customs warehouse or ship chandler shall be included.
- ⁽⁷⁾ The registration number(s) of rail-wagon or lorry and the name of the ship should be given as appropriate. If known, the flight number of the aircraft.
In case of transport in containers or boxes, the total number, their registration and seal numbers, if present, should be indicated under point 7.3.
- ⁽⁸⁾ Keep as appropriate.
- ⁽⁹⁾ Complete if appropriate.
- ⁽¹⁰⁾ Date or dates of slaughter. Imports of this meat shall not be allowed when obtained from animals slaughtered either prior to the date of authorisation for exportation to the European Community of the territory mentioned in footnote ⁽⁴⁾, or during a period where restrictive measures have been adopted by the European Community against imports of this meat from this territory.
- ⁽¹¹⁾ Complete as appropriate.
- ⁽¹²⁾ The colour of the signature shall be different to that of the printing. The same rule applies to the stamp other than those embossed or watermarked.
